I chair a subcommittee with the CJCC Criminal Justice Coordinating Committee where we are trying to assess what the need would be for an assisted living facility for those involved in the criminal justice system. We wonder if there is a fair number of defendants either in custody or out, that are **not able to care for their daily needs due to either a physical or mental disability/condition.** Participants will be interviewed by an intake worker and an assessment tool will be completed. The assessment will be one interview and the information will be destroyed after the data is used.
