# MEMBER SPOTLIGHT DENNIS B. POLK

When asked to pen a profile of himself for the Bar Journal, Dennis Polk demurred. When asked again, he asked me, his son and fellow attorney, to write it instead. It is not Dennis' style to seek aggrandizement. For example, his firm, Holley, Albertson, and Polk, has never had a website, and his only social media account is a Facebook page he uses solely to keep up with his classmates, and see pictures of his grandchildren.

Fortunately for Dennis, I feel no such qualms. Dennis has come a long way for a kid born at home, on a farm, in what was then rural Longmont. In 1961, the family moved to Arvada, where Dennis' father worked at Coors, and his mother worked as a nurse. Dennis attended Allendale Elementary, Drake Junior High, and Arvada West High School, and remains deeply connected to all three, especially Arvada West.

Dennis then attended Colorado State, where he lived with his brother, Mike, who also went on to become an attorney (Mike recently retired from a 30+ year career as the Assistant City Attorney for the City of Arvada). After college, Dennis attended the University of Denver College of Law, where an anonymous donor awarded Dennis a full scholarship, after it looked like he was going to leave school due to the cost of tuition. To this day, we do no know who provided the scholarship.

After graduating with honors in 1978, Dennis began his practice with the firm of Holley, Boatright, Villano, under his mentor and life-long friend, George Holley. He also (in probably the smartest move he has ever made) married my mom, Pamela. They have three sons, and six grandchildren, who are his favorite things in the world. Dennis has coached youth sports for over 40 years, and his "coaching tree" includes over a dozen professional athletes, as well as high school and college coaches. More importantly to Dennis though are the "young people" who still regularly reach out to him to thank him for the lessons they learned from him on the football field, wrestling mat, or baseball diamond.

In 1984, Dennis became a partner in the firm, which was renamed Holley, Albertson & Polk, and at which he practices to this day, in the areas of insurance coverage, construction defect litigation, and general commercial litigation. However, Dennis would tell you that he is first and foremost, a trial lawyer. At last count, Dennis has tried over 300 civil jury trials, ranging from a recent Agistor's lien for an old friend, to insurance coverage cases that have reshaped the law around the country.

2024 marks Dennis Polk's 46<sup>th</sup> year of practicing law, starting in the era of hand-Shepardizing cases, submitting typewritten briefs via courier, and extending into our modern practice of ediscovery and endless email. However, one thing has never changed: Dennis Polk has been, and will continue to be, a professional in every sense of the word.

#### **AWARD OF MERIT**

Awarded to the **attorney member of the First Judicial District Bar Association** who primarily practices in this District, and has provided distinguished service to the Bar and the community deserving of our Association's highest recognition.

#### FREDERICK J. MYERS PROFESSIONALISM AWARD
