
PROCLAMATION First Judicial District Bar Association



MEMBER SPOTLIGHT STEPHEN COOK

I grew up in South Bend, Indiana, and attended the business school at Indiana University before graduating from Valparaiso University Law School. During my earlier travels to Colorado, I discovered my deep connection to the state and knew I wanted to make it my home. That dream became a reality when I officially moved to Denver after graduation in 1996. From the moment I arrived, I felt a sense of belonging that has stayed with me ever since.

I didn't actually know anyone in Colorado when I first moved here. However, through mutual friends, I met Curtis Smith, and we became fast friends. Later, we formed Smith & Cook, LLC, in 2005. Additionally, I'm deeply committed to my role as an advisory board member of Metro Volunteer Lawyers, where I serve as the 1st JD liaison, ensuring access to justice for those who may otherwise struggle to find it. I have previously volunteered for Family Tree/Karlis Center, presenting at their Women in Violence Clinic, served on the 1st JD Adult Diversion Council, the CBA Leadership Selection Committee, and recently became a member of the 1st JD Judicial Nominating Commission. These opportunities to give back to the legal community and the general public have been among the most rewarding aspects of my career. Receiving the 1st JD Award of Merit in 2023 was a humbling recognition of this work.
