

MEMBER SPOTLIGHT BECKY CLARK

When asked to reflect on my history, I find that I, like so many attorneys, have quite a few chapters.

I am originally from Nashville, Tennessee. I spent my adolescent years debating with adults on various topics. I attended a high school with strict dress code requirements. I tested, argued, and won against the school shoe code, which had a typo. This was the first time anyone ever asked if I wanted to be an attorney. The rest was history.

At 18, I left Nashville and headed off to Southern California for my undergrad years at the University of Redlands. During my years in Redlands, I did two semesters abroad, one in Salzburg, Austria, with a focus on the Holocaust, and the second in Washington, DC, where I studied criminal justice. I proceeded to attend law school at American University's Washington College of Law.

After law school, I was licensed in both D.C. and Virginia, and began my career in civil litigation. I then began my family. My daughter was born in Virginia, and when she was one year old, we moved to Colorado. My son soon followed, being born here in Colorado. When my children were young, I worked in the school system, as many mothers do. I have been a front desk assistant, school nurse, and special educational assistant. I also volunteered as a CASA, wanting to keep some touchstone in the legal system, and have some level of advocacy during the time I was raising my children.

When my children were older, I began to look for a return to the law and a potential legal practice. Given my work in the school system and as a CASA, family law seemed like a natural fit. I began working for Peter Ely, Esq., a sole practitioner who was headed towards retirement here in Colorado. Once licensed, I grew in confidence, experience, base knowledge and practice in family law, while shadowing until Peter's retirement.

I was subsequently hired by Travis Whitson and joined Whitson Family Law. With a full heart and caseload, I have been working and advocating for my clients in this practice. My love of finding that perfect case, statute, or rule continues to be my favorite part of advocacy.

My now grown children refer to me as Mom, Esq. My daughter just graduated from CU Boulder, where she studied astronomy. My son is a Sophomore at San Diego State University, where he is in the business school. I spend my weekends visiting my kids, practicing yoga, and playing with my two dogs, Lili and Rico.

There are many chapters to the story of how I arrived here in the 1st JD at this point in my career. Those chapters and that experience are what shapes my practice and focus on representing my clients. It is a privilege to work in this system and as an advocate. I do not take that role lightly and look forward to the next chapter here in Colorado.
